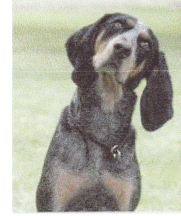

**ALL TERMS AND CONDITIONS OF THIS AGREEMENT ARE IN WRITING AND LISTED ON THIS**  
**CONTRACT. NO OTHER**  
**CLAIMS OR WARRANTIES, EITHER VERBAL OR OTHERWISE, APPLY.**

1. RETURNED CHECKS OR UNCOLLECTED TRAINING FEES: The signed agrees to pay a \$25.00 service charge for each returned check. In the event of late payment, it is understood that training will be suspended until due training fees are paid.
2. REFUNDS AND TRAINING CANCELLATION: The signed agrees that if he or she begins the Basic or Unlimited e-collar course and fails to complete same, he or she will pay an individual lesson charge for each lesson of \$65.00, including any lesson(s) not cancelled within twenty-four hours, plus a cancellation fee of \$75.00. Refunds will be given for cancellation of 8 week group courses prior to completing the first session minus a \$25 cancellation fee. After the first lesson there are no refunds. You may attend another class at a later time.
3. APPOINTMENTS: It is the sole responsibility of the owner to call or e-mail Precision K-9 to reschedule their next appointment.
4. THE SCHOOL WILL WORK WITH ONE OR TWO PEOPLE WHO MUST PRACTICE WITH THE DOG(S) AS PER SCHOOL DIRECTION. If the School deems the handler is NOT practicing with the dog as per the School's direction, PRECISION K-9, INC, reserves the right to suspend lessons until the handler resumes practice, as per School direction.
5. The signed agrees that he or she will pay any and all collection and court costs.
6. LIABILITY/LOSS OR DAMAGE: I/We the signed agree to release all liability from Precision K-9, Inc. and their representatives, and any and all landholders, leaseholders and their representatives where classes are held and its representatives from anything I, my dog, or someone else and/or his/her dog may do. I/We accept full responsibility for everything and anything I/we and/or my/our dog may do and hold harmless Precision K-9 against all actions, proceedings, claims, demands, losses, outlays, damages or expenses, including but not limited to legal fees which may in any way occur in consequence of dog training.
7. I am aware that my and/or my dog's picture may be taken and becomes the full property of Precision K-9, Inc.
8. Specific results can not be guaranteed.
9. GROUP LESSONS: It is also understood that the cost for a group course is for a complete course and refunds are not given, under any circumstances. The signed agrees to be on time for all classes with the proper equipment. The signed realizes that daily practice sessions are critical and must happen each week to fully prepared for the lesson.
10. BOARDING/TRAINING: Precision K-9, Inc. agrees to exercise due and reasonable care in the handling of the dog. The dog is to be properly cared for and fed in clean, safe sanitary quarters. All dogs are trained and boarded without liability on the school's part for loss, injury, disease, death, running away, hurricanes, theft, fire, acts of God, riots, acts of nature, injury to persons, other dogs or property by said dog or other unavoidable cause, PROVIDED DUE AND DILIGENT CARE WAS BEING EXERCISED. The signed also understands that should said dog become ill, it will be taken to the veterinarian of the school's choice or administer medicine or other advisable care, which, within the School's judgment is appropriate and such expense shall be paid promptly by the owner of the dog. Additional boarding time will be charged the regular boarding fee. Dogs with special grooming needs will be charged appropriately for extra grooming.
11. It is understood that the success of any training program depends upon owner participation and follow through. It is understood that if the owner does not apply the knowledge and utilize the tools in full, the training will be compromised. However, we do stand behind
